## LOCATION OF THE COLLEGE

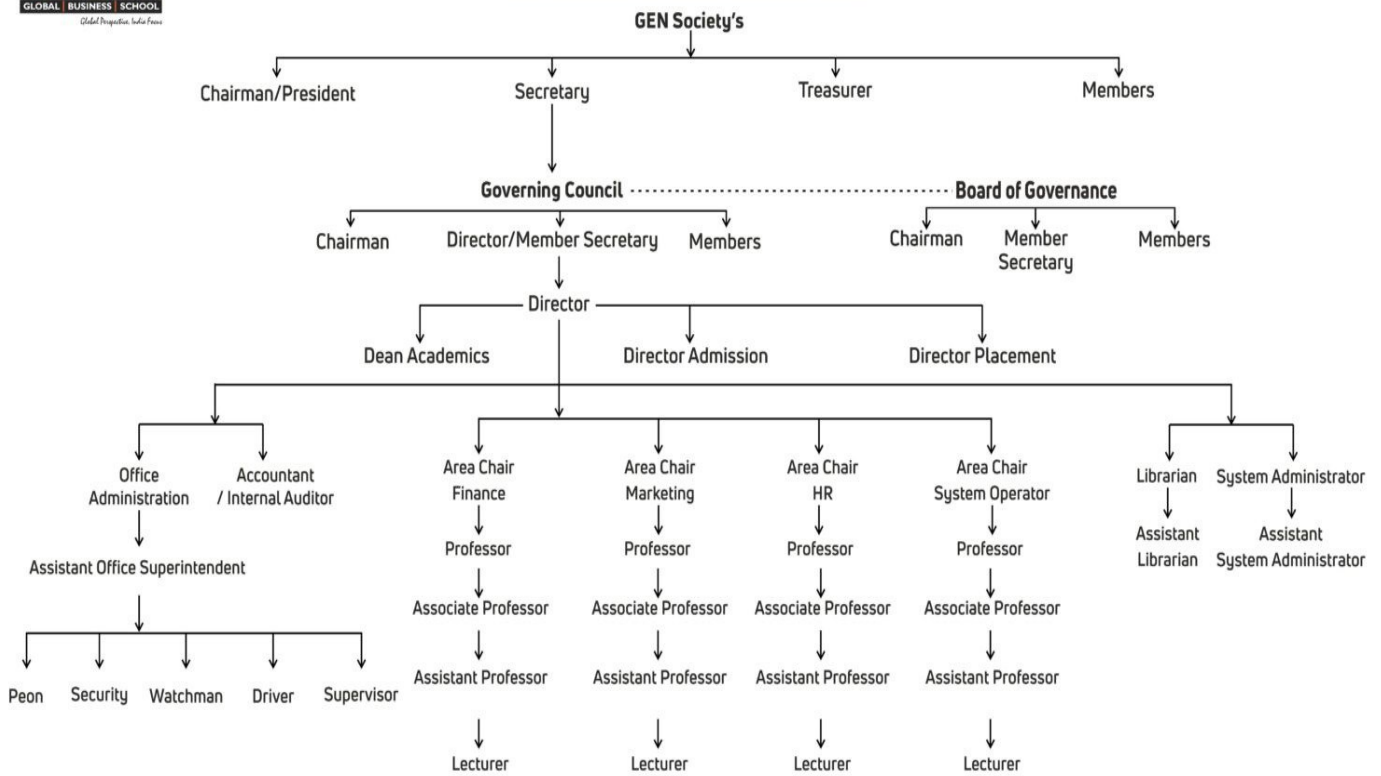
